
Notice of Budget Committee Meeting City of Culver & Culver Urban Renewal District

Notice of Budget Committee meeting: A public meeting of the budget committee for the Culver Urban Renewal District and the City of Culver, Jefferson County, State of Oregon, to discuss the budget for the fiscal year July 1, 2023 to June 30, 2024 will be held at Culver City Hall, 200 First Ave., Culver OR 97734. The meeting will take place on April 4, 2023 at 6:00 p.m. The purpose of the meeting is to receive the budget message and to receive comment from the public on the budget. A copy of the budget document is available online at www.cityofculver.net or may be inspected or obtained on at Culver City Hall between the hours of 8:00 a.m. and 5:00 p.m. This is a public meeting where deliberation of the Budget Committee will take place. Any person may appear at the meeting and discuss the proposed programs.

City Council Meeting – March 20, 2023

Workshop: Jered Reid on information on Public Purchasing, he explained the existing codes in regard to the public procurement process and explained the difference between what the city currently uses and what is required by the state. Roll Call: Mayor Bart Carpenter, Luke Middleton, Tim Woods, David Beck, Chuck Rushing, Josh Thody, and Scott Ough were present. The **AGENDA** and **CONSENT AGENDA** were approved with Thody declaring a conflict of interest. **INFORMATIONAL ITEMS:** Cindy Dix provided information and an update on the Park Site Plan and Oregon State Parks Grant Application. She explained she was requesting a grant for \$750,000 to install a skate park, pickleball court, bike pump track and parking. The grant needs to be submitted by Apr 1, interviews for some projects in June/July and a funding decision would be made in Sept/Oct. Councilors asked questions and Cindy explained the proposal and everyone understood the council is not bound by their decisions and the city will be responsible for all maintenance. **Citizen’s Input:** Jim Cyr feels the city doesn’t help business and he is opposed to the city banning the sale of drug paraphernalia. **Ron Reed** and others indicated some folks feel crack pipes could be considered nice pieces of art, a store is considered a “gatekeeper” to restrict minors from purchasing illegal products, the city should help small and local businesses. All the testimony opposed banning the sale of drug paraphernalia. **OLD BUSINESS:** Crystal Ough was appointed to the **Park Committee** (with councilor Ough abstaining from the vote).

Crawdad Festival: Denise Woods indicated CCIG is not sponsoring the festival. **Resolution 23-02** approving Informal Solicitation for Materials for Culver Park Pavilion Landscaping Project was approved. **Resolutions 23-03** and **23-04** (a Development Agreement and authorization to apply for a grant) were both approved. **NEW BUSINESS:** Following discussion about space limitations, the council decided to continue renting tables to the community. Proposed **Ordinance 23-02** Adopting Drug Paraphernalia regulations died for lack of a motion to approve. The first Presentation of **Ordinance 23-03** Adopting Changes to the code regarding Animals was approved with minor changes. **REPORTS:** Linda Victorine reported the Planning Commission position vacancy has been declared by the Urban Renewal District Board. Patti Carpenter reported the chamber would like to propose changing the Crawdad Festival Parade route. Jack Ickler provided an update on water levels and indicated NUID will be undertaking a canal piping project beginning in Oct. 23. Brent Schulke reported he received two new complaints plus another 3 today in addition to the 5 before. One has been resolved. Kim Symons reported via ZOOM and said she is working reduced hours but the light pole will be arriving shortly and she explained the need to purchase a mini-excavator instead of a multi-use tractor. Other equipment needs include a boss plow and a small street sweeper. Donna McCormack reported the city will be working on an IGA with Metolius for the Grader and an IGA with CO Public Works Assoc. for other equipment needs in addition to reporting a Street Maintenance Fee is being proposed in the budget this year. She also reported on the process Madras used for their entry sign, SEI filing, the Safe Routes to Schools community meeting and the budget committee meeting on Apr. 4th. Jered Reid, no report. **COUNCIL & MAYOR REPORTS:** Middleton asked about HB 3115 and the requirement to update our city ordinances and clarified the proposed Street Maintenance Fee could also be used to build sidewalks. Rushing reported they plan to have separate meetings for the Parks Committee and the Crawdad Festival. Ough reported a QR Codes is now available for people to sign up to receive notice of website changes, having a city facebook page is not proposed at this time but he would like to the website to be more engaging. Thody, Beck, and Woods had no report. Mayor Carpenter reported he has been attending the LOC Legislative Updates and the Madras Pioneer report on the historical documents provided to the city and he will be looking into how to protect them. The meeting was adjourned at 9:02 p.m.
