City Council Summary Minutes - Feb. 27, 2023

Call to order & Roll Call: Mayor Bart Carpenter and Councilors Luke Middleton, Tim Woods, David Beck, Chuck Rushing and Josh Thody were present. Select City Councilor: Mr. Scott Ough and Mr. Michael Gilbert were interviewed and Scott Ough was selected and sworn into office. The Consent Agenda was approved with Planning Commissioners Joanne Heare and Becky Jordan being reappointed and Linda Victorine being appoint to fill the PC position. Danny and Caroline Zook were reappointed to the Budget Committee Members. Presentations: Courtney Sneed with the Madras Area Parks & Rec District invited Culver residents and leaders to participate in the District Planning Project. Citizen Input: Linda Victorine asked about plans for a car charging station. Councilors expressed their opinions and Patti Carpenter will look into it and report back. Cindy Dix indicated there may be grants available for that purpose. OLD BUSINESS: Ordinance #2023-01 - An Ordinance Adopting Change to Culver Code Chapter 8.16 - Nuisances was formally adopted by the council. The Code Enforcement Committee plans to meet once more to review the animal ordinance then disband. **NEW BUSINESS:** The Pavilion Landscape Project Scoping was presented and the project explained with the council authorizing proceeding with the project. The council discussed proposing an ordinance to ban the sale of certain items associated with federally controlled substances. The council directed the attorney to draft an ordinance for consideration. STAFF REPORTS: Linda Victorine reported the Urban Renewal District has met all the legal requirements. Patti Carpenter reported on the Chamber of Commerce and indicated the kiosks are ready to be installed. Jack lckler reported the area should expect about the same amount of irrigation water as last year and the study is moving forward to evaluate using water from Lake Billy Chinook. Nuisance Abatement Officer, Brent Schulke reported he has been working on 5 properties, 1 is completed, 1 has received notice to fine and three are making progress on complying. Kim Symons invited councilors on a tour of the city and she will be not be working in the field for a while but is available. Donna McCormack reported the Safe Routes to Schools group will be in the city on April 12th with a community meeting in the evening; the city-wide yard sale is scheduled for June 17th; the Planning Commission is working on a site plan and conditional use for the proposed Taphouse, a site plan application for the skate park property and the flood plane ordinances. The city is no longer classified as a low/moderate income community according to Business Oregon. Jered Reid was authorized to work on the city's public purchasing ordinance and the council will have a workshop on it. COUNCIL & MAYOR REPORTS: Tim Woods reported he would like discontinue renting tables and chairs to the residents (The council will discuss this at the meeting in March) and to look at ways to save energy costs in the buildings. He also indicated he would like the council to consider purchasing lots in the new subdivision for pocket parks and increase public notice of vacancies. Dave Beck attends the COIC meetings and they will give a presentation next month covering what services they provide. Chuck Rushing reported the park committee will be meeting next week for a variety of topics including the Crawdad Festival. Josh Thody would like to propose an Entry Monument and decorative lights. Scott Ough was appointed as the Public Relations liaison and will work on ways to better inform the public. Mayor Bart Carpenter reported he will be starting conversations about merging the city into the fire district and is looking into curbside recycling for the community. The meeting was adjourned at 8:20 p.m.
