A Note from your Code Enforcement Officer

Recreational Vehicle Usage - The City of Culver is aware many residents in Culver own or use camp trailers, fifth wheels, motorhomes and similar recreation vehicles to increase the quality of their lives and spend time with family. It is also known that the above types of vehicles are used to provide housing for displaced relatives and friends going through hard times. It is important for Residents and property owners to understand the Culver Municipal Code allows for recreational vehicle usage within the city however, not without limitation. Culver Municipal Code 8.16.050 (19) allows for the use of Recreational Vehicles by visitors on the resident's lot, for a period not to Exceed 21 days in any consecutive six month period. A tip, set time limitations on the Duration of visitors staying in recreational vehicles on your property. We all need a little help sometimes however the usage of recreational vehicles for permanent housing within the City of Culver is not permitted and subject to Abatement.

**City Council Meeting – April 17, 2023**

Workshop: Presentation by Tammy Baney with COIC to provide information about the services they provide and what is available. **CALL TO ORDER**, Mayor Bart Carpenter, Tim Woods, David Beck, Chuck Rushing, Josh Thody, and Scott Ough were present. The **AGENDA** https://www.cityofculver.net/sites/g/files/vyhliif7881/f/agendas/agenda_3-20-23.pdf and **CONSENT AGENDA** were approved. A **Planning Commission Vacancy** was declared. **INFORMATIONAL ITEMS: Citizen's Input:** Mr. Paul May from Metolius reported he is running for election to the Jefferson County ESD board and he is currently the Planning Commission Chairman and Municipal Judge for the City of Metolius. **Presentations:** A special meeting for the **Public Purchasing Presentation** will be scheduled. Jered Reid gave a **Presentation on House Bill 3115** and advised an ordinance will be forthcoming to address the issues. **OLD BUSINESS :** The second presentation of **Ordinance 23-03 – An Ordinance Adopting Change to Culver Code Chapter 6 – Animals** was approved. **NEW BUSINESS: Discuss Planning Commission Decision appeal.** – Jered Reid explained the options available to the council regarding how to proceed with the appeal and the council decided to hold and “on the record” process at the next meeting on May 17th. **Provide Update and Review Project List** – Donna McCormack presented the update on the prioritized project list. Council discussed the process followed to determine the priority and how the list was generated. Concern was expressed about the lack of public input and it was suggested the Crawdad Festival would provide a good opportunity to get input. **Scope of Work for Community Center Concept Plan** – Troy Baker and Kimberly Stroup with COLE Architects introduced themselves and presented the Scope of Work for the Community Center. They explained what each step would be and why it was important as well as what they would provide throughout the project. The project would provide the city with the information necessary to apply for grants and answer important questions such as “What would it look like?”, “How much would it cost?” and “What services would be provided?” etc. The council approved the Scope of Work and asked to include phases so the council could review the results to decide if they wanted to continue with the project. **Review/award auditor services**– Donna McCormack presented a summary of the audit proposals and the council decided to table the decision until the next meeting so they would have more opportunity to review each of the proposals. **REPORTS: Public Works: Kim Symons** reported 1) She has been working on an Equipment proposal; 2) The trees have been planted around the pavilion and in the park. 3) She is experiencing splash pad issues; 4) They will be working on the three-year maintenance issues for the sewer irrigation system. 5) She has been researching the equipment needed to purchase that will meet the long-term needs of the city. 6) Enclosing the east side of the shop is being considered. Jack Ickler reported irrigation water is being turned on and Haystack Reservoir is full. Administration, Donna McCormack reported: 1) Requested guidance for the Juneteenth Holiday. 2) The city will be working on website policies. 3) Comments received from the public regarding the cost to rent the new pavilion. 4) The cost estimate for the city hall tech upgrades exceeded the budget so the plan it to proceed right after the first of July. 5) She requested vacation in May, the request was approved. **COUNCIL & MAYOR REPORTS:** Ough indicated he is working on the website. Thody reported a rock chuck is eating the wiring on vehicles. Rushing reported the park committee members each have taken on an element of the Crawdad Festival. Beck reported he is attending the COIC meetings and the Safe Routes to Schools public input map is available on the website and all comments are welcomed. Woods asked about dogs in the baseball diamond and was told it is not allowed for dogs to be at large and the park committee will be reviewing the proposed park regulations. Mayor Carpenter had no additional comments. **ADJOURNMENT:** The meeting was adjourned at 8:55 p.m.
