- 2/25/24** **Appoint Budget Committee members.**
- 3/6/24** **Publish first notice of Budget Committee meeting:** A public meeting of the budget committee for the City of Culver, Jefferson County, State of Oregon, to discuss the budget for the fiscal year July 1, 2024 to June 30, 2025 will be held at Culver City Hall, 200 First Ave., Culver OR 97734. The meeting will take place on the 3rd day of April 2024 at 6:00 p.m. The purpose of the meeting is to receive the budget message and to receive comments from the public on the budget. A copy of the budget document will be available online on the City of Culver website or may be inspected or obtained on or after March 27, 2024, at Culver City Hall between the hours of 8:00 a.m. and 5:00 p.m. This is a public meeting where deliberation of the Budget Committee will take place. Any person may appear at the meeting and discuss the proposed programs with the Budget Committee. (Publish twice between 5 & 30 days before meeting)
- 3/20/24** **Publish second notice of the Budget Committee Meeting.**
- 4/3/24** **Hold the first Budget Committee meeting.** Schedule additional meetings as required.
- 5/31/24** **Deadline for approval by the Budget Committee.**
- 6/14/24** **Publish Notice of Budget Hearing and Financial Summary:** A meeting of the Culver City Council will be held on June 17, 2024, at 6:30 p.m. at Culver City Hall, 200 First Ave., Culver OR 97734. The purpose of this meeting is to discuss the budget for the fiscal year beginning July 1, 2024, as approved by the City of Culver Budget Committee. A summary of the budget is presented below. A copy of the budget may be inspected or obtained at Culver City Hall between the hours of 8:00 a.m. and 5:00 p.m. (Financial Summary information is included 5 – 30 days before the hearing.)
- 6/17/24** **Hold Budget Hearing.**
Enact Resolutions to: Adopt Budget; Make Appropriations; Impose and Categorize Taxes.
- 7/10/24** **Submit tax certification documents to the county assessor.** (Deadline July 15, 2024)
